Do not use genetically modified species for afforestation; Strictly control foreign species and prioritize the selection of local tree species;

3. 在森林经营活动中禁止使用 WHO、FSC 和农业部禁用的化学药品；

Prohibit the use of chemicals prohibited by WHO, FSC, and the Ministry of Agriculture in forest management activities

4. 大力提倡反腐倡廉政策，承诺遵守反腐法，不进行、不接受任何形式的腐败和贿赂，严格遵循公平竞争规则，引导联合体及成员和相关利益团体（供应商）依法办事，自觉抵制腐败现象。
